COUNCIL TAX and PRECEPTS

The Council is recommended to resolve as follows:

- 1. Note that the Council, at its meeting on the 17th January 2019, calculated its Council Tax base for the year 2019-20 as 61,465 [item T in the formula in Section 31B(1) of the Local Government and Finance Act 1992, as amended (the "Act")].
- 2. Calculate that the Council Tax requirement for the Council's own purposes for 2019-20 is £84,284,496
- 3. The following amounts be calculated by the Council for the year 2019-20 in accordance with Sections 30 to 36 of the Act.
 - (a) £474,257,496 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act.
 - (b) £389,973,000 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act.
 - (c) £84,284,496 being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council, in accordance with Section 31A(4) of the Act, as its Council Tax requirement for the year.
 - (d) £1,371.26 being the amount at 3(c) above divided by the tax base at 1 above, calculated by the Council, in accordance with Section 31B of the Act as the basic amount of its Council Tax for the year.
