

Transfer to Secondary School - Key Information

Parental Responsibility – You can only submit an application for a school place if you have parental responsibility for the child. If you share parental responsibility, all those who share responsibility must be in agreement about the preferences and information submitted. If we receive conflicting preferences for the same child we will **not** process the application unless provided with further evidence about which preferences should be accepted, for example a family court order.

Your Preferences – You can apply for up to 3 preferences of school. We strongly recommend you name your catchment or nearest school as one of these preferences.

We operate an equal preference system which means that if you submit 3 preferences, we consider each of them separately on its own merits according to the oversubscription criteria for that school.

When we come to allocate places, if we can offer you more than one of your preferred schools, we will allocate the one which was your highest ranked preference.

If we cannot offer your child a place at any of your preferred schools, we will allocate a place at the nearest alternative school with places available. This could be a school some distance away from your home address and may not be your catchment or nearest school if that school has been filled.

Changing your Preferences – If you submit your application online before the deadline date, you will not be able to change it. You must contact the School Admissions Team as soon as possible for advice on how to make a change.

If your change of preference is received late it will be accepted but not dealt with until after all of those preferences that we received on time. Any changes received after 6 January 2027 may not be actioned until after the national offer date.

How to apply – Applications should be made online at [Secondary school applications | Hull](#) from 1 September 2026 to 31 October 2026.

You will need a valid email address which must be registered before you can apply. Full instructions are given on the council website. You will receive an email confirming submission of your application. Supplementary Information Forms (SIFs) – If you are making an application for St Mary's College based on your religious belief you will need to complete a Supplementary Information Form (SIF). A SIF has been provided with your application letter, but copies can be obtained from the school or can be downloaded from the Hull City Council website.

Aptitude Tests – if you wish to make an application for a place at, St Mary's College under the music aptitude criteria or at Liberty Academy or Sirius Academy West under the sporting aptitude criteria, you must clearly indicate this on your application. Tests for sporting/music aptitude are arranged by the school and they can allocate up to 10% of their published admission number based on aptitude. Details of what is involved in the testing can be found on the schools' website or can be obtained from the school.

Medical/Exceptional Reasons – Some secondary schools consider this as part of their oversubscription criteria. If you believe your child has a medical/exceptional reason that should be considered for one of your preferred schools, you will need to provide supporting evidence from a doctor or professional practitioner. This should be attached to your online application form or posted to; School Admissions Team, Room 128, Guildhall, Alfred Gelder Street, Hull, HU1 2AA.

Children with Special Educational Needs – Where an Education Health and Care Plan (EHCP) is in place there is a different admission and appeals process. Children who do not have an EHCP but who may be on the SEN register should apply online as indicated.

Your home address – You may only use one address when making an application. This must be the address at which the person with parental responsibility and child are ordinarily resident at the time of application. We may check addresses against other records held by Hull City Council in accordance with the authority's Data Protection Registration. Alternatively, we may request evidence of GP registration or child benefit address.

Addresses must be permanent addresses and not those of relatives or temporary addresses such as staying with family, childcare arrangements.

Where there is joint residence, the address used should be the address at which the child is resident for the majority of the school week. If this is evenly split then parents/carers must jointly select one address and use this on the application. Places obtained using fraudulent information may be withdrawn.

Change of address – If you change your address after submitting your application you must send us the relevant proof. The address used to determine your child's allocated school is your address at the closing date for applications. If you move home before the closing date you must notify The School Admissions Team as soon as possible. We can consider a change of address made after the closing date if the evidence is received before 6 January 2027.

Currently and Previously Looked After Children – If your child is 'looked after' (that is in the care of a Local Authority), was previously 'looked after' and is subject to a residence or child arrangement order; a special guardianship order or has been adopted from care, including adopted from care out of England; they will have a higher priority in the oversubscription criteria of your preferred schools. You must therefore, indicate this on your application.

Distance from Home to School – we measure distance from home to school with the Routefinder GIS mapping system using the shortest safe walking route. We don't use roads without pavements or paths with the exception of Hawkesbury Street to James Reckitt Avenue, the footbridge across the railway line from Priory Drive to Hotham Road North, and St Ninnians Way. Some schools use other mapping systems as stated in their admission arrangements.
