Food Hygiene Rating Scheme: Request for a re-inspection rescore

Notes for businesses:

- As the food business operator of the establishment you have a right to request a re-inspection for the purpose of re-rating if you have taken action to rectify the non-compliances identified at the time of inspection.
- You can make one request for a re-inspection per each planned statutory inspection by the food safety team and you can make this at any time after the statutory inspection provided that you have made the required improvements.
- You must provide details of the improvements made with your request, **including supporting evidence** such as photographs where appropriate.
- If the local authority considers that you have provided sufficient evidence that the required improvements have been made, the
 local authority will notify you and then make an unannounced visit. This will take place within three months. The local authority
 officer will give you a 'new' food hygiene rating based on the level of compliance that is found at the time of the re-inspection –
 you should be aware that your rating could go up, down or remain the same. We will look at all the areas of food safety within the
 business, not just those raised as an issue at the last inspection.
- To make a request for a re-inspection, please use the form below. There is a charge for carrying out the re- inspection of £242. This payment should be made online at www.hull.gov.uk, by selecting 'Make a Payment' and following the instructions on screen for 'Food Hygiene Rescore Revisit'. Please have the six digit reference number which can be found on the top right hand corner of the letter (which was sent containing the original rating score) ready to hand when you make the payment.
