## Did you know...

The quickest and easiest way to contact us about your Council Tax is to register for an account online at [www.hull.gov.uk/mycounciltax](http://www.hull.gov.uk/mycounciltax) Once registered you will be able to securely manage your account, view bills and payments, set up and manage Direct Debits, apply for discounts and exemptions. You will just need a few details to register, these are shown on the bill you have just received. We recommend registering now, while your bill is still to hand.

The easiest way to pay your Council Tax is by Direct Debit which can be set up over 10 or 12 months if your first payment starts in April, and on 1st, 7th, 14th, 21st and 28th day of each month. ## Frequently Asked Questions

### What does my Council Tax pay for?

As well as providing more than 400 different services to you and your family, including waste management, road maintenance, social care and support, your Council Tax also contributes to the costs of Humberside Police and Humberside Fire and Rescue Service.

### Why has Council Tax increased this year?

Most of the Council's funding is provided by the Government. However, we now receive much less money from the Government than in previous years. The Council must legally set a balanced budget to meet its expenditure for the next financial year, and an increase to Council Tax of 4.99% is required to ensure vital services can continue to be provided.

### Can I pay by Direct Debit?

Yes, Direct Debit is the easiest way to pay your Council Tax and ensures no payments are missed and no additional costs are incurred, such as when the Council has to take court action to collect missed payments. ### Can my Direct Debit be spread over 12 months rather than 10 months?

### Can I get any help to pay my Council Tax?

Depending on your circumstances, help is available:

- If you are of working age, on a low income and have less than £6,000 in savings or capital, or if you are a pensioner with less than £16,000 in savings or capital, you can apply for a reduction in your Council Tax.
