## INTRODUCTION

The purpose of the Ward Plan is to demonstrate how we intend to work towards revitalising our neighbourhoods by collaborating with our residents to tackle the issues that matter to you on your doorstep. We want to improve outcomes for local people on local issues that affect your quality of life, and further enhance the community leadership role of your local councillors.

The Plan was developed using ward knowledge gained through conversations with local people and reviewing all customer engagement/enquiries with the council and partners.

This marks the start of a new way of collaborating with our communities and compliments work underway with the Community Plan at a city level plus the emerging Area Plans. As well as changing what we do, this Plan will change how we do things. Residents, businesses, and communities will be involved in new developments with new and easy ways for people to have their say and get involved.

Although this is a 5-year plan, we will review our ambitions and priorities annually from April, 2024 with direct input from you, as residents of the ward.

## OUR PRIORITIES

Priority 1 - To maintain and improve the environment including open and green spaces.

Priority 2 - To improve safety and wellbeing.

Priority 3 - Improve cleanliness of local environment.

## PRIORITY 1 – MAINTAIN AND IMPROVE THE ENVIRONMENT INCLUDING OPEN AND GREEN SPACES.

### **What we will do to deliver this priority**

- 1) Work with community groups to bring about improvements to the environment that local residents want to see.
- 2) Protect grass verges and other highways assets from damage caused by parked vehicles.
- 3) Support healthy school holiday programmes in the ward.
- 4) Support funding to organisations who aim to deliver these aims and objectives.
- 5) Provide a network of high-quality open spaces and natural environments.
- 6) Work to create, sustain and improve an environment that promotes physical and mental wellbeing across all settings.
- 7) Consider alternate funding and project initiatives by partners that directly improve the environment.

### **How we will deliver this priority**

- Respond to all reports of vehicles causing damage to verges and other highway assets by assessing options available and funding preventative measures to prevent similar behaviour
- Look to provide future investment from the ward budget and other funding sources to improve the play offer in local parks.
- To ask residents via engagement activities such as ward forums, meetings, newsletters and social media what they would like to see in their open spaces.
- Support the delivery of the 'Active Travel Strategy' at the local level, supporting the cycling and walking culture within our neighbourhoods and reducing our impact on climate change.

## PRIORITY 2 – IMPROVE SAFETY AND WELLBEING

### **What we will do to deliver this priority**

- 1) Work with local residents, Humberside Police and partners to address and reduce crime and anti-social behaviour in the community.
- 2) Respond to all reports of vehicles causing damage to verges and other highway assets by assessing options available and funding preventative measures to prevent similar behaviour
- 3) Support the delivery of campaigns to improve the health and wellbeing of residents and continue to promote campaigns via engagement, social media and community noticeboards.
- 4) Work with local community organisations that help foster and promote healthy activities and past times.
- 5) Attend regular street surgeries and engagement events with partners such as the police and neighbourhood nuisance.
- 6) Continue to work with business and residents to grow the defibrillator project across the ward.
- 7) Work with community centres to aid in the delivery of services to residents for health and wellbeing activities.
- 8) Consider alternate funding initiatives by partners to maximise funding opportunities for the ward.

### **How we will deliver this priority**

- Meet regularly with partners including the police to respond to emerging issues and agree a plan of action to tackle issues raised.
- Consider funding initiatives by partners that directly target crime reduction measures.
- Provide ward funding for the provision of target hardening equipment including window and door security and shed and garage alarms.
- Continue to provide funding to Probe Limited to carry out home security visits as a result of referrals from the police
- Update residents and partners on actions taken to improve road safety.
- Continue to liaise with businesses and residents to grow the defibrillator project across the ward.
- Maintain good working relationships with community centres keep in regular contact – help to explore funding and engagement opportunities.
- Continue to support and champion organisations providing assistance to those adversely affected by the cost of living crisis, food poverty etc.
- Support the delivery of the 'Active Travel Strategy, support the cycling and walking culture within our neighbourhoods and reducing our impact on climate change.

## PRIORITY 3 – IMPROVE CLEANLINESS OF LOCAL ENVIRONMENT

### **What we will do to deliver this priority**

- 1) Develop environmental schemes to enhance areas.
- 2) Maintain street and area cleanliness exploring new and alternative approaches to improving the environment.
- 3) Work with Love Your Neighbourhood, environmental crime officers on environmental inspections to combat problems in neighbourhoods in terms of graffiti, contaminated bins, and litter.
- 4) Continue to address fly tipping/waste management issues across the ward.

### **How we will deliver this priority**

- Liaise with partners to develop planting schemes to improve the environment and improve the look of the area.
- Provide additional waste bins in selected areas
- Audit and arrange regular cleaning of street furniture.
- Develop local initiatives that respond to identify environmental issues.
- Consider alternative funding initiatives by to maximise environmental opportunities within the ward.
- Undertake regular patch walks, to identify concerns and generate solutions.

## CONTINUING THE CONVERSATION

### YOUR VIEWS MATTER

We are committed to listening and involving you in decisions that affect you. As a result, we understand that there will be times when we need to engage with you on specific ward-based issues. This will ensure that we collect valid and robust data, in a consistent and accurate way, which can confidently be used in evidence-based decision making, with the resident voice at its heart.

We will continue to engage with you through a variety of other ways, this could be public forums, specific localised meetings, street surgeries with partner agencies such as Humberside Police or Humberside Fire and Rescue, ward-based events, newsletters and through our social media platforms. Your ward councillors will continue to be active in the ward and hold regular surgeries for you to engage with them directly.
