Food support

Free school meals vouchers

Eligible children will receive a £15 voucher for the following school holidays -

May half-term 2025 Summer holidays 2025 October half-term 2025 Christmas holidays 2025 February half-term 2026

Your voucher can only be used to buy food.

Community food aid

Our community food aid providers can help if you can't afford the food you need.

Fuel and energy support



Support for low-income households to improve energy efficiency, including -

School clothing grant

To alleviate some of the pressures on Hull parents and carers with the cost of school uniforms, contact your school for further details.

Housing tenancy support

To alleviate some of the pressures on both our tenants and private tenants to prevent homelessness and protect tenancies. This support is not for the payment of rent or rent arrears. If you are a Council tenant, please speak with your Tenancy Officer for more information. If you are a private or Housing Association tenant, please speak to your housing provider.

Targeted help for pensioners

Those pensioners with the most limited incomes who do not receive Pension Credit and who are in receipt of higher rate of Council Tax support will receive a £200 credit applied to their Council Tax account.

You do not need to apply for this, the credit will automatically be paid onto your Council Tax account. This will be applied to accounts between January 2026 and March 2026.
