**Permit Details:**

The following Environmental Permit is issued under Regulation 13 of The Environmental Permitting (England & Wales) Regulations 2016 (EP Regulations), as amended and varied under Regulation 20, to operate an installation which carries out an activity covered by the descriptions in Section 2.3, Part A2(a) to Schedule 1 of the EP Regulations.

Section 2.3 Part A2(a) of Schedule 1 states that an installation will require an A2 Environmental Permit to operate if the activity carried on involves the surface treating of metals and plastic materials using an electricity or chemical process where the aggregated volume of the treatment vats is more than 30m<sup>3</sup> and where the activity carried out at the same installation as one or more activities falling within;

1. Part A(2) or B of Section 2.1 (ferrous metals)
2. Part A(2) or B of Section 2.2 (non-ferrous metals)
3. Part A(2) or B of Section 6.4 (coating activities, printing and textile treatments)
